

PINE ISLAND COVE BOCCE CLUB RULES- 2018

1. Each team has 4 players, 2 on each end.
2. One Captain will call the flip to see who gets the pallina and the color of the balls.
3. The winner of the flip will throw the first ball. The opposite team then will have to be closer or keep throwing until they beat his. The pallina must go past the center line. If the team that throws the pallina does not go past the center line, then the other team gets to throw it.
4. If a player throws an opponent's ball it shall be replaced with the correct colored ball.
5. If player throws out of turn that ball will be removed from play.
6. If a player throws their ball before the pallina that ball comes back and the other team throws the pallina.
7. If a thrown colored ball does not go past the center line, it will remain on the court.
8. If thrower hits a bail out of the court, that ball is dead. If a ball hits the pallina out of the court, the opposite team gets to throw the pallina anywhere in the court as long as it goes past the center line (do not remove any balls).
9. When during the volley, there is a tie; the last player who threw the ball will throw again.
10. If there is a tie at the end of the volley, tied balls are removed and the next color ball gets the point.
11. Spouses cannot play on the same team. That includes subs. No subs the last 2 weeks unless approved by the referees.
12. You can only sub 2 times per game day unless approved by referee.
13. If requested, Referee will provide measurements at any time during the game.
14. Stepping over the fault line is discouraged. All players are to stay at their end of the court behind the foul line during play.
15. Players must be in the court when they are throwing the ball(s) and the player must leave the court when they have thrown their ball(s).
16. Disqualification: Players shall act in a sportsmanlike manner at all times. Any act which is deemed as poor sportsmanship: e.g., offensive language or gestures or action or words which engender ill-will if flagrant, may result in disqualification.

ARRIVE 15 MINUTES BEFORE YOUR TEAMS SCHEDULED START TIME.**

Each player will be asked to donate \$5.00 toward the annual year end party and expenses incurred during the year. Captains will give these funds to the Treasurer.
